DECISION

N 205-N of 23 February, 2012

ON SUPPLEMENTING № 1819-N DECISION OF 15 DECEMBER, 2011 OF THE GOVERNMENT OF THE REPUBLIC OF ARMENIA

The Government of the Republic of Armenia decides:

- 1. To do the following supplementations and changes in Nº 1819-N decision of 15 December, 2011 of the Government of the Republic of Armenia on confirming the model forms of the declaration of tax year property, income and related person of a high-ranking official and of the declaration of a high-ranking official's property, income and related person existing on the day of the high-ranking official's assumption of formal duties or termination of formal duties:
- 1) to add after "the declaration of the tax year property, income and related person of a high-ranking official" words of the title of the decision the following words: "the declaration of the tax year property and income belonging with a property right to a high-ranking official's spouse, parent, adult and unmarried child co-residing with him/her".
 - 2) in Paragraph 1 of the decision
- a. to formulate the model form (Annex N 1) of the declaration of the tax year property, income and related person of a high-ranking official approved by Sub-Paragraph 1, with new editorship in accordance with Annex N1;
- b. to formulate the model form of the declaration of a high-ranking official's property, income and related person as of the day of the high-ranking official's assumption of formal duties or termination of formal duties approved by Sub-Paragraph 2, with new editorship in accordance with Annex N 2;
 - c. to supplement the Paragraph with a new Sub-Paragraph 3 with the following content:

"3) the model form of the declaration of the tax year property and income belonging with a property right to a high-ranking official's spouse, parent, adult and unmarried child co-residing with him/her – in accordance with Annex N 3".

3) to supplement the decision with new Annex N 3 (model form of the declaration of the tax year property and income belonging with a property right to a high-ranking official's spouse, parent, adult and unmarried child co-residing with him/her) – in accordance with Annex N 3.

2. This decision enters into legal force from the day following the formal publication.
